

"LIGHT UP A LIFE" CAMPAIGN BY NCJW RETURNS

After a very successful launch last year,
National Council of Jewish Women, Greater
Kansas City Section is asking its members
and the community at large to Light Up
A Life for the less fortunate in Kansas City
and Israel.

By contributing to the Light Up A Life Campaign donors will help NCJW implement and enhance its current programs that benefit women, children, and families. Contributions to the annual campaign will help to fund the following:

Hello Israel - NCJW volunteers present curriculum enrichment activities about Israel to public school sixth graders by taking them on an imaginary trip to Israel.



Kids and Teachers=School (KATS) - NCJW works with M. E. Pearson, Caruthers, and Douglas Elementary Schools in Kansas City, Kansas. NCJW members organize monthly birthday parties for the students during lunchtime, donate school supplies, tutor, provide gifts over the holidays, and miscellaneous needs.

Parties for the Blind - NCJW volunteers provide lunch, entertainment, and transportation in association with AlphaPoint for visually impaired adults.

Scholarships - NCJW awards new and ongoing scholarships to area high school and college students.

Domestic Violence Focus - NCJW sponsors the Silent Witness Exhibit, the Women Helping Women Luncheon and other activities to educate the community about domestic violence.

Advocacy - Members advocate for women, children and families on legislative issues considered at the local, state, and federal levels; upcoming participation includes the Benchmark Luncheon, which involves judiciary nominations and the Roe v. Wade Day in Topeka.

Community Education - NCJW is planning an Interfaith Luncheon on March 3 to explore the role of contemporary women in Judaism, Islam, and Christianity.

Israel - Donations to the campaign also support programs in Israel, such as the NCJW Women and Gender Studies Program at Tel Aviv University. Through Yad B'Yad- Hand in Hand with Israel, NCJW provides grants for literacy, childhood development and enrichment programs.

Campaign co-chairs and board members, Janet Mark and Melanie Allmayer, are continuing the Donor of Distinction level of giving for donors who contribute a minimum of \$1500 to the campaign. Donors of Distinction will be recognized throughout the year and will be honored at the June 13th awards evening. Did you notice our new look? The National Office has its eye on the future. After extensive research and thought, the National Board has approved a new branding strategy for the organization which creates a unique voice for a unique organization. The first component is the new logo. Turning thought into action has always been essential to NCJW. Now it is essential to our new logo. Highlighting the W reflects our emphasis on women - our members, our audience, and often the recipients of our support. Turning the W on its side spotlights the changing role of women. It also creates a double arrow, pointing forward to graphically convey our belief in looking ahead and moving toward a better future.

The logo colors - a strong blue and vibrant green - build on this visual language. The blue provides impact and suggest strength. The green represents "go" and symbolizes power, growth and energy. The tag lines, "A faith in the future. A belief in action," reflects NCJW's essence. These words reveal our confidence in the promise of tomorrow and the action that will bring us to it. And they speak of values of the Jewish Faith - values that will flourish in the future and continue to be expressed through activity. They are a verbal snapshot, the simplest way to talk about ourselves and the important work that we do.

You will see the new logo and color scheme on all NCJW materials so that our activities, publications and communications will be instantly recognizable.

In addition to the new brand and tag lines, the National Board has developed a positioning statement which summarizes our organization:

For over a century, the National Council of Jewish Women has been at the forefront of social change campaigning the needs of women, children and families - while courageously taking a progressive stance on such issues as child welfare, women's rights and reproductive freedom. And that pioneering spirit continues to this day. Parties for the Blind Resumes Fall Schedule

Chairperson Symie Menitove of NCJW's Parties for the Blind sums up all the good reasons for the program that now enters its 68th year. She explains, "The joy on the faces of our visually impaired friends when they come together for an afternoon of entertainment, good food and camaraderie tells a wonderful story."

The 2003-2004 schedule of luncheons resumed on October 21 at the Central United Methodist Church. A special feature of the kick-off luncheon, sponsored by the Sisterhood of Beth Shalom, spotlighted the group's Mitzvah Singers in a diversified program of musical selections.

As the longest-running project of the NCJW, Greater Kansas City Section, *Parties for the Blind* is funded in part from a bequest established by Section member **Beth Lyon**. In addition to special funding by individual donors, support is received through community participation.

For the third season, AlphaPointe Association for the Blind coordinates volunteer drivers who transport guests to the church from the all over the Greater Kansas City Area. 

Dear Mrs. Jacobson.

Thank you for selecting me to receive the National Council of Jewish Women Scholarship, for the 2002-2003 academic year. Please also extend my thanks to everyone on the scholarship committee and all those connected with the scholarship selection process. I am proud to be a recipient of your organization's scholarship, and am grateful to your organization for providing me with an opportunity to achieve my educational aspirations. If you look to my college transcript, you will see that I have challenged myself every semester both in course load and difficulty. I am committed to growing in my personal and intellectual scholarship and the course directions that I have chosen in college have proved difficult, but extremely rewarding. The success in my matriculation would not have been possible without the assistance from your organization, and I value your continued commitment to my intellectual and professional growth.

I must also apologize for my poor communication with your group over the previous academic year. As I recall, one of the scholarship conditions was to regularly communicate with your committee about any changes in my academic or professional goals. New Program In Israel

KIDS FOR KIDS

It's been three years since the start of the suicide bombings in Israel, and the number of young victims continues to multiply. To be sure, too many of these children have become part of the fatality statistics or have been permanently maimed. There is, however, another class of young victims referred to as those who have "fallen between the stretchers". These are children who have not suffered physical injuries, but severe psychological trauma as a result of the suicide bombings. Kids for Kids (K4K), a project funded by NCJW's Yad, was established to help these children.

Although the psychological effect on these children runs the gamut, many of them have been overwhelmed by feelings of powerlessness and helplessness as a result of the terror attacks. Unfortunately, with the current economy in Israel, few government services have been allocated to address the needs of these children. K4K was created to fill this gap.

Staffed by numerous volunteer psychologists, K4K conducts workshops to engage these children in numerous innovative, therapeutic activities. The primary tool being utilized in the K4K workshops is called Digital Storytelling. Each participating child is given the opportunity to write his or her own personal story, which is then produced in a CD-video format with voice-over, photography, artwork and video capability (see the following story). The premise is that stories, rather than logical arguments, are the best means for these children to find their inner voices and to enable them to overcome their feelings of helplessness.

This year, NCJW will restore the "voices" of more than 100 Israeli kids through the K4K Workshops. The grant money for this pioneering program was provided by NCJW through Yad b'Yad. This is the first Yad b'Yad sponsored-program that specifically services victims of terror. Yad b'Yad has already allocated \$77,400 for eighteen other projects in Israel, including children's literacy and empowerment programs for at-risk populations.

In 2001, COMVAC's Faith Committee and SAFE-HOME conducted a study that found 84% of female Johnson County domestic violence victims had a close relationship to their religious communities. Less than 50% of those women sought assistance from their clergy. The reasons revolved around fear of not being believed, shame, and embarrassment.

To help reach those victims, the Faith Committee initiated the CASE project, a congregation-based support and education program for members facing family


abuse. Volunteers will listen to victims, validate their stories and, and explain the resources available to them. Volunteers will handle each call with sensitivity and confidentiality. The first training took place September 30th. One out of the three persons who applied to volunteer for this program from the Jewish Community was able to attend. Our faith community's volunteers will serve the entire Jewish Community, not just their congregation. COMVAC's Faith Committee hopes to hold the next training on March 2nd. 

NCJW URGES OVERTURN OF GLOBAL GAG RULE AND RESTORATION OF UNFPA FUNDING

"The National Council of Jewish Women (NCJW) strongly opposes the Bush administration's continuing efforts to eliminate funding for international family planning services. These draconian changes in US overseas funding policies for family planning place the lives of countless thousands of the world's poorest women, men and young people at risk.

"In 2001, President Bush re-imposed the global gag rule by issuing an executive order barring the US Agency for International Development (USAID) from giving aid to international organizations that use their own funds to provide abortions or abortion counseling, or to lobby their own governments on abortion policy. Recently, the White House expanded this global gag rule to cover family planning funds administered by the US Department of State and officially withdrew funding from the reproductive Health for Refugees Consortium, which provides reproductive

health and HIV prevention services for refugee women.

"Compounding the issue is the administration's with-drawal of funding for the United Nations Population Fund (UNFPA). In January 2002, the White House froze the \$34 million UNFPA allocation approved by Congress over concerns regarding UNFPA's program in China. In May 2002, however, a State Department investigation team returned from China having found no evidence that UNFPA had knowingly supported or participated in programs coercing abortion or sterilization. The team recommended the release of the UNFPA funds. Despite these findings, the administration still refuses to restore funding. An NCJW leader, who recently visited UNFPA sites in China as part of an interfaith mission, corroborated the State Department team's findings.

"NCJW urges Congress to overturn the global gag rule and restore UNFPA funding immediately."

NCJW OPPOSES A CONSTITUTIONAL MARRIAGE AMENDMENT

"The National Council of Jewish Women (NCJW) supports the right of gay and lesbian couples to legally affirm and protect their relationships through marriage and opposes efforts to amend the constitution to create a federal definition of marriage as only between a man and a woman.

Those who oppose the right of gay and lesbian couples to marry generally cite religious beliefs as the basis for their opposition. Senate Majority Leader Bill Frist recently stated that he supports the proposed constitutional amendment because "marriage is a sacrament." The constitutional guarantee of religious liberty and separation between religion and state requires that the US government refrain from defining who may marry.

Gay and lesbian couples in this country are forming partnerships, having children and creating families and will continue to do so. To deny couples in these committed relationships the same legal benefits accorded spouses in heterosexual marriages is prejudicial, counterproductive and morally offensive.

Discrimination on the basis of sexual orientation must be eliminated. NCJW endorses and resolves to work for the enactment and enforcement of laws and regulations that protect civil rights and individual liberties for all."

NCJW OPPOSES EXPANSION OF THE PATRIOT ACT

"The National Council of Jewish Women (NCJW) opposes attempts to enact new legislation that would expand the powers of the Justice Department and other law enforcement agencies beyond those already granted in the Patriot Act, enacted in October 2001. While we support our government's efforts to fight terrorism and apprehend terrorist, we believe there must be a balance between the intelligence community's need to know and an individual's constitutionally guaranteed right to privacy and judicial due process.

The Patriot Act of 2001, as enacted, contains provisions that dangerously infringe on civil liberties including:

Section 215, which allows law enforcement to access a wide array of personal information including medical, business, library, education and genetic records without cause;

Section 213, which permits "sneak and peek" searches of homes prior to obtaining a search warrant;

Section 415, which allows for the indefinite detention of non-citizens certified by the Attorney General as terrorists, whether or not they are criminally charged, and bypasses judicial review. The scale is already out of balance and our constitutionally guaranteed rights are at risk.

Three new bills have been introduced in Congress that would grant excessive authority to law enforcement agencies and further infringe on civil liberties and constitutional rights. The "Pretrial Detention and Lifetime Supervision of Terrorist Act of 2003," the "Antiterrorism Tools Enhancement Act of 2003," and the "Terrorists Penalties Enhancement Act of 2003" would erode due process by granting the Justice Department even broader latitude to subpoena people and records, question individuals in closed proceedings, and deny suspects bail and access to an attorney all without judicial review or grand jury protections.

NCJW strongly opposes legislation that would further erode civil liberties. We urge Congress to defeat these bills. Further, we call on Congress to restore the checks and balances required in a democratic society by enacting pending legislation to correct the most egregious provisions of the Patriot Act and safeguard our constitutional rights."
